SYRIA EARTHQUAKE RESPONSE

Facilitation for Entry of Emergency Relief Supplies and Personnel to Syria

07 February 2023

Background

After multiple earthquakes hit southern Türkiye and Syria on 6 February, thousands of people remain in urgent need of humanitarian assistance. The earthquakes and their aftershocks resulted in thousands of casualties and massive destruction of houses and critical civilian infrastructure across governorates in the north, central, and coastal parts of Syria; Aleppo, Lattakia, Tartous and Hama among other locations.

The Government of Syria (GoS) has appealed for the support of the international community to respond to the urgent humanitarian needs arising from the earthquakes. In an effort to allow humanitarian aid from outside Syria to reach those in need, the Syrian Ministry of Foreign Affairs and Expatriates (MoFAE) will ensure timely facilitation for customs, visa and other entry procedures for organizations requiring support to send supplies or staff to support affected people.

For supplies/personnel outside Syria

Many member states and humanitarian organizations not currently operational within Syria have expressed willingness to send humanitarian aid and expert technical staff to Syria by land and/or air. In order to initiate the process and due to the urgency of relief required, the GoS has designated focal points for customs/visa-related matters for supplies and personnel capable of providing services to the affected populations. MoFAE has indicated that it will urgently approve visas within two days. All inquiries for support should be directed to the below individuals.
